Bridgett Fleming N 22nd St. came to address the board about the renting of the muni building. She states she's putting together a fund raiser for the boy's baseball team at Lanphier High School and is asking the board to not charge the \$200 rental fee as the group does not have much money. The fund raiser money will be spent towards new uniforms and accessories. Trustee Bentley made a motion to let them have the muni building for free, Trustee Pellagrini seconds that motion. **Roll Call:** Trustee Bentley, Hopkins, Hoehn, Jarrett, Pellegrini, Rhodes **Vote:** Yea 6, Nay 0.

Mickey Mann (Village Engineer) came to address the board about road repairs on Milton to the railroad tracks at a cost of about \$48,000. He also wanted the board to discuss repairs at Wolfe - Wesley and Albany-Wolfe. We are receiving excellent prices on asphalt and we are hoping those prices extend into next year.

The board would like to know how Mickey Mann can find the village more money (grants) for these repairs. Mickey has mentioned before income survey, perhaps the village would like to revisit that option. The survey would determine the income of the village residents and perhaps qualify the village for additional grants.

President Ochs states according to Treasure Cave about 60% of the village is now rentals.

President Ochs would also like to update the board on the issue that Attorney Myers has been handling at 1529 Stephens. Attorney Kravens states this process would be for the order to demolish the property and collect fines.

Trustee Hopkins states the board trustees need to be included in the application, interviewing and hiring process, whatever happened to the Police hiring committee. Pete states there is a committee but ultimately the police chief picks his own crew.

Trustee Hopkins it appears we are back to the hiring and firing again. Officer Byerline turned in his resignation two weeks ago what happened in that two week time frame.

President Ochs states he was unaware officer Byerline was leaving until recently.

Trustee Hopkins states President Ochs is missing the point, trustees don't get a choice, from now on when voting on any hiring he will just vote present or nay and if there are enough Trustee's voting then President Ochs will get his way.

Trustee Jarrett made a motion to hire Cory Reynolds as full time officer, Trustee Bentley seconded that motion. **Roll Call:** Trustee Bentley, Hopkins, Hoehn, Jarrett, Pellegrini, Rhodes **Vote:** Yea 4, Nay 0. Present 2.

Trustee Bentley suggests enough is enough and that we move on. She would also like to add that when voting present that means you go along with the majority.

New Business: President Ochs would like to discuss amending the Ordinance regarding discretionary spending. Currently we are allowed to spend \$300 he would like it to be raised to \$750. Often there are times when we buy rock, tables etc. That \$300 just is not enough. Attorney Cravens explained the Ordinance in more detail. Trustee Rhodes would like to read over it and review at the next meeting.

Pete would also like to discuss raising the water unit. Currently we pay \$6.40 per unit to CWLP the resident pays \$9.57 to the village, that's a \$3.17 profit for the Village. The Village of Jerome pays \$10.06 per unit. Unfortunately we do not have a lot of options when it comes to increasing revenue for the Village. We have had 3 water main breaks over on Wolfe and we need to start replacing pipe. We currently have \$120 thousand remaining after paying our bill to CWLP. He would-like-to see the water unit raised up an additional \$1.00 and put that increase into an infrastructure savings.

Trustee Rhodes states he would like to call a committee meeting on this so that it may be discussed further. President Ochs feels like that would be a great idea.

Trustee Pellagrini asked Treasurer Cave is the Village for Jerome 60% rental homes? Treasurer Cave states no it is not.

Her plan consist of up to three food trucks in the parking lot along with a pizza place on one end of the existing building and gaming parlor on the opposite end. She knows the current ordinance does not allow the village any additional liquor license but she's asking for that ordinance to be amended.

An issue was brought up about the distance from this business to the church. It is thought to be 100 feet but Treasurer Cave will look into this distance further. President Ochs wanted to know what time frame Elizabeth was looking at. She would like to start as soon as possible. The board will discuss further and get back to her.

Timothy Voss – 2363 Cincinnati came to discuss an issue he has with his neighbor who races cars and proceeds to spray mud on his garage. President Ochs states this matter would need to be discussed with the new police chief; the board will not get involved with legal issues of this type.

Elizabeth Shanks the manager of the bar in the village would like to ask the board to put a stop to the police officers parking in her parking lot behind her sign. It deters patrons from entering her bar when they think they will be stopped for drinking and driving upon exiting the lot. President Ochs states he agrees and will mention this issue to the police chief.

Mickey Mann (Village Engineer) discussed the gutter work on North grand in front of Quick Silver and the drainage issue on Wesley. Several bids received for both locations. President Ochs will speak with Mr. Farley the owner of Quick Silver to see if he will split or pay all the cost to fix North grand.

President's Report: President Ochs questioned if the water department goes to turn on water at a residence for a new customer does the customer have to be present at the time. What if the water is turned on and the resident is unaware of a leak or running toilet that runs the bill up? Who would be responsible for the bill and or damages? Attorney Myers states anything from the street to the meter would be on the village, anything from the meter to the home would be the responsibility of the resident. Gary Nation states when they turn on the meter they allow four rotations, if it appears to be moving faster than normal they turn it off.

In a past meeting a resident came to complain about trees that hang over in front of the street lights. President Ochs took a drive through the village and he does see some issues that need addressed. He will work on obtaining estimates for tree trimming.

Clerk Bates: Nothing to report.

Treasurer Cave: We will need to pass the Appropriations and would like to get approval by end of August.

Standing Committees:

Public Improvements, Municipal Building and Recreation-Trustee Hopkins — Hot dog stand still has not been removed? President Ochs states items such as an oven, refrigerator, and air conditioner are still inside the hot dog stand what need to be done? Those items are to be junked take to salvage yard and put money back into the village.

Building Permits and Zoning-VACANT Trustee Rhodes reported that a letter was sent to the Learning Nook regarding the fine for not getting a fence permit. It has since been paid by the business.

Recycling, Public Health and Safety- Sabrina Nudo-Absent

Streets & Equipment-Trustee Bentley- Absent. Trustee Hopkins states we were to have a vehicle meeting but that never took place, we are down to one running truck.

Water/ Sewer- Trustee Rhodes reports that water will be going up \$.16 per unit with no sewer increases. To our knowledge this is the final water increase that was to be spread out over several years.

President Ochs would like to see a newsletter sent out explaining the increase. Lisa states it is time for the next newsletter she will make sure it contains this information.

Trustee Rhodes would also like to ask the board to postpone water shut offs for the 20th, due to the excessive heat wave.

He also wanted to address the fact that 7 to 8 inch gap between the fences allows for weeds to grow. Who would be responsible for the upkeep? Trustee Rhodes explained the owner failed to get a permit from the village before placement of the fence. Had they done so this issue would have been addressed. Trustee Rhodes went on to explain a letter has been sent to the daycare and we are addressing the situation.

President's Report: Pete wanted to let everyone know that the orange truck is down with radiator issues. We have 2 bids for repair but need one more; we are looking at about \$3000 in repair. The truck has several other issues brought to the board's attention such as oil pan leak and air brakes. The truck is really oversized for what the village uses it for. The white truck also has fuel issues; it broke down and had to be towed. It was suggested by the board to have the road committee (Joe, Sabrina, Janice) meet to discuss what needs to be done about these issues.

Clerk Bates: Nothing to report.

Treasurer Cave: Canny accounting bill for the auditing of villages records comes to \$5200. Trustee Bentley makes a motion to pay the \$5200, Trustee Rhodes seconds that motion. Roll Call: Trustee Bentley, Hopkins, Nudo, Rhodes Vote: Yea 4, Nay 0. Absent. 1

Lisa's still working on the treasurer's report.

A call was received from a resident regarding no water due to a leak on Sangamon Ave. we are unsure why a village resident would be without water when the leak was so far over. Lisa called about the issue and was told the valve closest to the leak could be turned off so they have to turn the valve closer to the village off. Everything has since been fixed.

Standing Committees:

Public Improvements, Municipal Building and Recreation-Trustee Hopkins – The muni building consistently loses money. He would like to make a motion to increase the rental fee by \$100 effective immediately, Trustee Bentley seconds that motion. Roll Call: Trustee Bentley, Hopkins, Nudo, Rhodes Vote: Yea 4, Nay 0. Absent. 1

Maintenance to the muni will be done out of his own budget but he wants the village employees to paint on village time when they have a free moment.

The hot dog stand needs to come down, it will provide additional parking for the muni, again he would like this done on village time by our guys when time permits.

President Ochs agrees this could be done by village employees and to see what the cost of a 22 yard dumpster would be. He would also like Joe to call about the power, gas and water hook ups to make sure they are all turned off. In addition the light and pole needs to be removed.

Building Permits and Zoning-VACANT Trustee Rhodes wanted to add that fence permits must be obtained before fences installed.

Recycling, Public Health and Safety- Sabrina Nudo- at the last meeting she discussed the properties within the village that are mowed based on the agreement with Mr. Scott. She would like to recommend that the board suspend the mowing of 5 out of the 8 properties originally addressed. Should those properties grow out of hand she will send the customary letters to the property owner's. Public: Lisa Parrish addressed the board regarding her rental of the muni building on May 28th. Her wedding reception was held that evening and the air conditioning was out causing her reception to end in half the time she expected. They contacted the village police, who sent someone over to look at the air, but it was still too warm and her guest ate and then left. She not only wanted to make the board aware of an issue with the air but to ask that she get at least part of her money back. Upon further discussion by the board Mrs. Parrish will receive half of her \$150 rental fee back. Trustee Murphy made a motion for half refund, Trustee Hopkins seconded. Anthony Casper addressed the board regarding the street lights in the village. It appears several throughout the village are covered by over grown trees, and he would like to know what the village plans on doing about the issue. President Ochs states tree trimming of this nature is not done by the village, but he will make a call to Ameren.

Mickey Mann (Village Engineer) addressed the board in regards to the Approval of the Wesley St. maintenance. Once approval accepted it would take 15 days to schedule. We are probably looking at some time in July. President Ochs would like to know the price per linear foot. Mickey state it would be \$43.00 per linear foot.

Trustee Hopkins made a motion for Approval of the Wesley St. maintenance, Trustee Bentley seconded that motion. **Roll Call:** Trustee Bentley, Hopkins, Murphy, Nudo, Rhodes **Vote:** Yea 5, Nay 0.

Mr. Mann then asked about the muni building parking lot. The board states it has already been addressed and rock was placed on lot as a temporary fix at this time.

President Ochs would like to know if grants are available to the Village for storm sewage. Mr. Mann states grants are available but do not cover the upfront cost. The village would front the money. Treasurer Cave states she does know we looked at this several years ago and she thought it was called CDAP grant. In order to receive this grant surveys were done door to door throughout the village to check on the poverty level of the village residents. President Ochs would like to see this looked into further, as he has received several complaints about the storm sewage.

Village Police chief Feliccia along with officer Rally address the board in regards to obtaining new body cameras. The current body cameras that we purchased a few years ago are cheap and not serviceable due to software issues. It's proposed that they purchase 3 cameras and hardware. Trustee Murphy makes a motion to purchase new body cameras for police department up to \$2500 dollars, Trustee Bentley seconded that motion. Roll Call: Trustee Bentley, Hopkins, Murphy, Nudo, Rhodes Vote: Yea 5, Nay 0.

Minutes of 5/16/17: Trustee Hopkins made a motion to pass the minutes, Trustee Murphy seconded that motion.

Bills: Trustee Rhodes makes a motion to pay the bills; Trustee Bentley seconds that motion. Roll Call: Trustee Bentley, Hopkins, Murphy, Nudo, Rhodes Vote: Yea 5, Nay 0.

President's Report: Nothing to report.

Clerk Bates: Nothing to report.

Treasurer Cave: The reciprocal agreement needs signed, this is a confidential report showing what businesses pay in taxes to the village. Trustee Murphy makes a motion for Approval of Azavar to Municipalities gas/electricity bill, Trustee Bentley seconds that motion. Roll Call: Trustee Bentley, Hopkins, Murphy, Nudo, Rhodes Vote: Yea 5, Nay 0.

Trustee Bentley makes a motion to pass Ordinance Authorizing Expenditures Pending Adoption of Annual Appropriations, Trustee Rhodes seconds that motion. Roll Call: Trustee Bentley, Hopkins, Murphy, Nudo, Rhodes Vote: Yea 5, Nay 0.

Standing Committees:

Public Improvements, Municipal Building and Recreation- Trustee Hopkins – his committee had a meeting but he wishes to discuss the outcome at the next board meeting. He did add, he has some experience with insurance and states as long as we have DRAM insurance we are covered. Attorney Myers will review the rental contract for the muni building and submit revised to Treasurer Cave.

Building Permits and Zoning- OPEN POSITION Trustee Rhodes has and issues he has addressed regarding a fence placed without obtaining a permit. The Learning Nook had an existing chain link fence but has since put up an additional wooden fence without the removal of the old chain link fence. He feels they should have obtained a permit and suggests we fine the business for failure to do so. President Ochs states we also have a home that backs up to that business with over grown lawn. He states the business did not remove the existing chain link fence because other residents have tied their fences into that existing fence. Trustee Rhodes

would be providing the Learning Nook with a copy of the Village ordinance and will check back with the board on the results.

Recycling, Public Health and Safety- Trustee Nudo- She has taken time to review the properties that Mr. Scott has listed to mow. It appears that we are having him mow properties within the village that belong to residents and not the village. Therefore we should be filing liens on the homeowner's property and not taking the money from the village. The addresses in question are the curve on Water & Enterprise, the field at Albany by tracks, Water St. from North grand to Converse, Easement on keys and easement on North grand & Stephens. After further discussion the board agreed that we should not be mowing those properties without placing liens.

President Ochs also discussed 2333 Keys and the lawn issue at this residence. He wanted to thank Trustee Nudo for all her hard work. Several complaints have been received by Trustee Nudo about this property, so the village found someone to mow and to remove the junk from the back yard of this property. We will be filing a lien towards this property for all fees required.

Streets & Equipment- Trustee Bentley- Nothing to report other than we have a lot of potholes in the village and we will be working on getting those filled.

Water/ Sewer- Trustee Rhodes- He has received a request to extend a late water bill payment and has denied he will not approve.

Police & Human Resources- Trustee Karen Murphy- Nothing to report. She would like to discuss pay increases for police officers. President Ochs states we will go into Executive session for that discussion. Trustee Murphy makes a motion to leave regular session and proceed to executive session, Trustee Bentley seconds that motion.

New Business: Removal of tree on the curve by Dollar General. Trustee Bentley states she will have to have this placed out for bids because the one and only bid was over \$500. Treasurer Cave did not believe that the needed to place out for bid based on that amount. Upon further discussion President Ochs states that amount if low for the removal of a tree that size, he would like to look into this further.
